

**MEMORANDUM OF UNDERSTANDING (MoU)**

**BETWEEN**

**Global Education & Technoworld**

**&**

**District Social Welfare Office, South Salmara Mankachar District**

This Memorandum of Understanding ("MoU") is made and entered into on this 02 day of September, 2024, by and between:

1. **Global Education & Technoworld**, an educational institution duly registered and having its principal office at Hatsingimari (hereinafter referred to as "GET" or "Party 1"),

**AND**

2. **District Social Welfare Office**, South Salmara Mankachar District, having its office at Hatsingimari, South Salmara Mankachar District (hereinafter referred to as "DSWO" or "Party 2").

**WHEREAS**

1. GET is engaged in providing quality education and skill development programs, particularly focusing on computer education for students from economically disadvantaged backgrounds.

2. DSWO (BBBP) is committed to promoting social welfare and is actively involved in supporting initiatives aimed at enhancing educational opportunities for needy students in South Salmara Mankachar District.

NOW, THEREFORE, both parties hereby mutually agree to the following terms and conditions:

**1. Objective**

- The objective of this MoU is to provide Computer Education (Diploma in Computer Application - DCA) to needy students in the South Salmara Mankachar District. GET will offer the DCA course for these students, and DSWO (BBBP) will financially support from GOI Flagship Scheme BBBP the initiative by covering the course fees.

## 2. Duration of the Course

- The Diploma in Computer Application (DCA) course will be of 6 (six) months duration, starting from the date of enrollment of the selected students.

## 3. Number of Beneficiaries

- The number of **girls' beneficiaries** eligible for the program will be mutually agreed upon by both parties and will be subject to the availability of resources and funding.

## 4. Course Fees

- The course fee for each student enrolled in the DCA course will be **₹4000/-** (Rupees Four Thousand only), payable by DSWO (BBBP) to GET.
- Payment of the fee shall be made by the District Social Welfare Office (Beti Bachao Beti Padhao) as follows: 50% of the total amount will be paid within 30 days after the enrollment of the beneficiaries and will be transferred directly to the designated bank account of Global Education & Technoworld (GET). The remaining 50% will be paid upon successful completion of the course.

## 5. Selection of Students

- Needy students who fulfill the criteria set by DSWO (BBBP) will be identified and recommended for the program.
- A list of eligible students will be provided to GET by DSWO (BBBP) for enrollment in the DCA course.

## 6. Responsibilities of Global Education & Technoworld (GET)

- GET will provide quality instruction, materials, and access to necessary facilities for the DCA course.
- GET will ensure that the students receive practical and theoretical knowledge as per the standard curriculum for the DCA course.

## 7. Responsibilities of District Social Welfare Office (DSWO) (BBBP)

- DSWO (BBBP) will be responsible for identifying and recommending eligible needy students to GET for the DCA course.
- DSWO (BBBP) will ensure that the course fees of **₹4000/-** per student are paid to GET as per the terms outlined in this MoU.
- DSWO (BBBP) will monitor the progress and impact of the program on the students, in collaboration with GET.

## 8. Monitoring and Evaluation

- Both parties shall hold quarterly review meetings to assess the progress of the program, address any issues, and ensure its smooth functioning.

## 9. Termination

- Either party may terminate this MoU by providing 30 days' written notice to the other party. However, in case of such termination, any financial commitments made prior to the termination shall be honored.

## 10. Dispute Resolution

- Any dispute arising from the implementation of this MoU shall be resolved amicably through mutual discussions. If a resolution is not reached, the matter shall be referred to arbitration in accordance with the Indian Arbitration and Conciliation Act, 1996.

## 11. Amendments

- This MoU may be amended by mutual written consent of both parties at any time during the term of this agreement.

## 12. Effective Date and Validity

- This MoU shall come into effect on the date of signature by both parties and shall remain valid for a period of 1 (one) year, unless extended by mutual agreement.
- IN WITNESS WHEREOF, the undersigned, duly authorized representatives of both parties, have signed this MoU on the day and year first above written.
